You may also have noticed that our slideshow and our regularly updated webcoms have moved and changed shape.

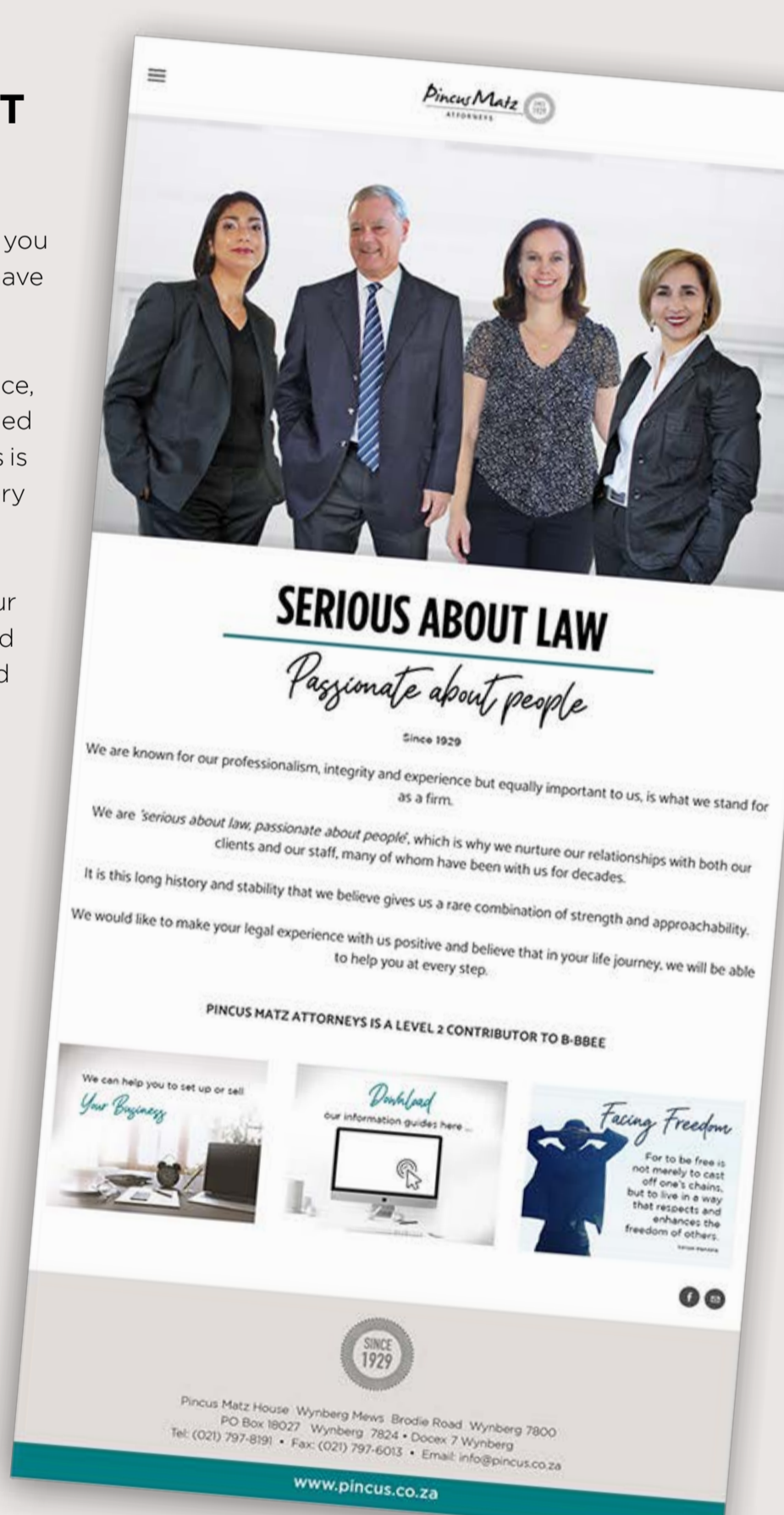
However, this year we will be making more changes to the information and the way we present our services as well.

## Face to Face with Pincus Matz family

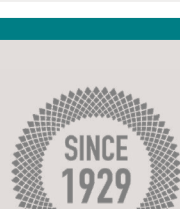
Two members of the Pincus Matz family celebrated their birthdays in April.
