

An Antenuptial Contract is entered into by a couple who decides not to be married 'In Community of Property'. It stipulates whether the 'Out of Community of Property' marriage will be with, or without, the Accrual System. The contract must be signed by both prospective spouses in the presence of a Notary Public before the marriage, and must then be registered in the Deeds Registries office within the prescribed time period.
